Federal Financing Bank (FFB) announced the following activity for the month of January 2025.

FFB holdings of obligations issued, sold or guaranteed by other Federal agencies totaled \$216 billion on January 31, 2025, posting an increase of \$5.7 billion from the level on December 31, 2024. This net change was the result of an increase in the holdings of government-guaranteed loans of \$5.7 billion. The FFB made 32 disbursements and received 2 prepayments in the month of January.

The FFB also reset the interest rate for 21 loans guaranteed by the Department of Energy.
